Halal Statement of Nkwaleni Processors (Pty) Ltd

Nkwaleni, Kwa - Zulu Natal, South Africa

We declare for all products produced at Nkwaleni Processors (Pty) Ltd that

DECLARATION:

1. This serves to certify that all products that have been manufactured on-site at Nkwaleni Processors (Pty) Ltd are completely from fruit or vegetable origin and does not contain any animal derivatives or additives from animal origin.
2. All products are manufactured from sound, mature fruit by natural processes only, and were not produced with and / or do not contain any ethyl alcohol or any other intoxicating alcohol.
3. The puree, pulp or juice was extracted from the named fruit by processes regulated by the current EC Council Directive relating to fruit juices only, and was heat treated to inactivate pectolytic and other natural enzymes and then pasteurized, concentrated to remove a certain portion of water and packed frozen to guarantee sufficient reduction of the microbiological flora to meet the final product specification.
4. The product was obtained from the fruit by extraction, refining, enzyme inactivation, centrifugation (if low pulp), pasteurization, concentration, cooling and ambient packaging where after product is stored frozen.
5. No processes or derivative or additive was used in the manufacture of our products that are classified as Haram (unlawful) under Muslim judiciary law.
6. Neither enzymes, nor any GMO's were used that are of animal or alcohol origin. The company does not use any additives, allergens or GMO's in its processes.
7. The production facility at large and processing lines are wet cleaned with approved cleaning agents. At no point in time are any alcohol based or alcohol derived cleaning agents used in the cleaning and disinfection of the plant or processing lines.
8. The manufacturing process is at present not Halal Certified but is instantly certifiable and the product is definitely Halal suitable. Should the client prefer Halal status of the product, then Halal Certification can be immediately arranged.
